The 100th Anniversary of Provisional Government of Republic of Korea Forum: From the Korean independence movement to Contemporary Social Interactions of Korea and Taiwan.

The year 2019 is the 100th anniversary for the provisional government of the Republic of Korea. At this significant moment, it is important to review the history and the international relations between the Republic of Korea and the Republic of China.

The forum was opened with a keynote speech by Tae-Jin YI, professor emeritus of Seoul National University to examine the strategic cooperation and historical contribution between the two countries during the independence movement from a historical perspective. Followed by two panels titled with "Mr. Kim Koo and the Korean Independence Movement" and "Interactions and Future between the Republic of Korea and the Republic of China." New Reproductive Technologies and Global Assemblages: Asian Comparative Perspectives

Asia has seen new and emerging developments in Assisted Reproductive Technology (ART) in recent years. These include the steady rise of commercial surrogacy in Southeast Asia and India, the egg donation market in Taiwan attracting infertile women from China, Hong Kong, and Korea, as well as the presence of Denmark-based sperm banks sending sperm across the globe (including Asia). In addition, subsidizing IVF or ART as a policy mechanism to combat low fertility rate and the promotion of egg-freezing among single women coming from the medical community further reflect the complexity of these phenomena and how related discussions tend to roil society as a whole. With invited scholars from Australia, Denmark, Japan, Korea, Taiwan, and the United States sharing their individual work, this forum adopted an Asian comparative perspective and contributed aggregately to the investigation and dialogue of challenging issues concerning ART.



Events Promoting Comparative Understanding of South Korea and East Asia

July 2-3, 2019

The 16th EASP (East Asian Social Policy Network) Annual Conference

The 16th EASP (East Asian Social Policy Network) Annual Conference was held at the National Taiwan University from 2nd-3rd July 2019. Over 190 delegates from 16 countries came together in Taipei to discuss the conference theme: East Asian Welfare Futures: Between Productivism and Social Investment. The panels on the first day facilitated discussions about higher education expansion in East Asia, social policy change in the South Korean welfare state, social investment and gender equality in Taiwan, human rights conventions and food banks, and migrant worker employment and migration policies, respectively. The second day began with three additional panels on migration policies and governance in South Korea and Taiwan, the changes of the Japanese welfare model during the "lost decade", and discussions of migration and youth well-being in China and Cambodia, alongside additional paper streams.

Taiwan and South Korea share a number of similar patterns, trends, and policies of migration. Both Taiwan and South Korea practice exclusive migration regime in recruiting temporary low-skilled migrant workers. This has caused various abusiveness problems associated with situation of immigration without settlement. Both societies also receive a significant number of cross-border marriage migration, turning into quintessentially multiethnic and multicultural nations within a short period of time. This panel puts together researchers working on recent policy changes in Taiwan and South Korea to discuss ever growing challenges brought by these divergent groups of new migrants.

Traditional East Asian welfare states used to be viewed as the developmental welfare states which aims to pursue economic growth at the expense of social policy in order to catch up with the Western modernization. While this viewpoint explains the cases of Taiwan and South Korea from the end of the WWII well into their democratization taking place in the 1990s, the two countries have since then trodden in two different paths in response to the challenges of post-industrialization, globalization, and population ageing. This panel puts together researchers working on recent policy changes in Taiwan and South Korea to discuss ever growing challenges for democracy and welfare governance.

#MeToo in East Asia Forum

In October 2017, US mainstream media, the New York Times and the New Yorker, exposed that Hollywood's mogul movie producer Harvey Weinstein has for years been sexually harassing and assaulting women. Since then, #MeToo has taken hold on social media as a movement to fight against sexual harassment and assault, eventually making waves on a global scale. The movement has equally swept East Asia, although in different forms and scales in China, Japan, Korea, and Taiwan. Among these localized efforts, #MeToo in Korea has gained most momentum, its movement outlasting those in neighboring countries and most extensive in terms of the issues addressed. #MeToo in Japan has been comparatively contained where accusers remain anonymous and its impact limited on laws and policies.

Taiwan in comparison saw relevant media report but few mobilizations or protests for the #MeToo cause, oddly so when considering Taiwan's higher ranking in gender power and equality indexes among these East Asian societies. China's #MeToo on the other hand has been galvanized by overseas movements.

Whereas international media had given extensive coverage to the #MeToo movement, discussions in the academia has been insufficient and, where available, based on western experiences. This forum hence envisions a systematic exploration of #MeToo's developments and divergence in East Asia and has achieved a cross-referential understanding of the legal, social, political, and cultural implications of the movement.
